### **What are the fees for buying / selling at Heritage Eagle Bend for a single-family home?**

Transfer Fee: \$265

Working Capital: 4 months x \$373 monthly assessment = \$1,492

### **What if I purchase a home in HEB Master that is also in one of the Sub-associations?**

You'll pay the following fees for both the Master and Sub-Association, if you are purchasing a home in two (2) HOA's.

### **Master / Single-Family Home:**

Transfer Fee: \$265

Working Capital: 4 months x \$373 monthly assessment = \$1,492

Non-refundable

### **Traditions / Duplexes:**

Transfer Fee: \$50

Working Capital:  $4 \times \$237 = \$948$  OR (the monthly assessment depends on whether the owner pays own irrigation water)

Working Capital:  $4 \times \$194 = \$776$
